Resolution Plan submitted by the Company for acquisition of Binani Cement Limited ("BCL")

This is in continuation of our letters dated 14th November, 2018 and 19th November, 2018.

In terms of the Company's Resolution Plan approved by the National Company Law Appellate Tribunal, the Board of BCL has been re-constituted and BCL has become a wholly-owned subsidiary of the Company with effect from 20<sup>th</sup> November, 2018.

BCL has a capacity of 6.25 MTPA in the State of Rajasthan comprising an integrated cement unit with capacity of 4.85 MTPA and a split grinding unit with capacity of 1.4 MTPA. In addition, BCL has investments in subsidiaries in China and UAE.
